Why is a Rotary Mobile Health Clinic needed?

Studies have revealed that there are service gaps in obtaining convenient and affordable health care services in the Livermore Valley.

- A significant percentage of Livermore residents are uninsured or underinsured for medical coverage.
- More than 30 percent of the children in some Livermore schools have no health insurance.
- For many of those without insurance the only health services they receive are at the emergency room of ValleyCare Health System.

Rotary Mobile Health Clinic Services

Concerned community leaders and knowledgeable health care advocates have recommended a mobile health clinic as an effective method for bringing health care services to those in need. The Rotary Mobile Health Clinic will be staffed and operated by ValleyCare Health System and will offer:

- Physical exams: diagnosis and treatment for minor illnesses & injuries
- Immunizations and Flu Shots (ValleyCare Health System participates in a county electronic data base)
- Health screening for blood pressure, cholesterol and glucose levels for diabetes
- Referrals for medical and social services as needed
- Healthcare education for children and families
- Information and assistance with health insurance coverage

The Rotary Mobile Health Clinic will visit schools, community centers and other locations where youth, seniors and others in need of medical care have access. The Mobile Health Clinic will also be available for disaster relief services.
