The two Rotary clubs of Livermore formed the Rotarian Foundation of Livermore for the purpose of making substantial charitable gifts to deserving projects within Livermore's sphere of influence. Since their establishments as a tax exempt qualified charitable fun in 1987, the Foundation corpus has reached its target of \$1,000,000, which will allow us to support major projects in Livermore over many years. To date we have funded in excess of \$800,000 to support the local community.

The Mission of the Rotarian Foundation of Livermore is to improve opportunities for young people and promote community service for the benefit of all in Livermore.

Grant application will be evaluated using the following criteria:

- ✓ Benefit the young people of Livermore
- ✓ Promote community service in Livermore
- ✓ Meet an important specific need and have a significant impact in meeting that need
- ✓ Have an enduring and extensive community benefit
- ✓ Increase the effect of the Foundation grant through matching support or volunteer efforts.
- ✓ Must respect the race, creed and ethnicity of all beneficiaries.

Applications must be received not later than December 1<sup>st</sup>, 2010. Interviews for award finalists will be held in January 2011. Finalists will be presented to the regularly scheduled Board of Directors meeting in February 2011. Award winners will be notified in writing in March 2011, with presentation of funds in April, 2011.
